Rental Contract Terms & Conditions

Making Reservations

Quotes and proposals do not guarantee availability of rental equipment. Equipment will be reserved only upon receipt of a signed rental contract and a 50% non-refundable deposit. Final payment is due the day of installation, if you have not provided means for final payment, we will process remainder of funds on the credit card on file.

Cancellations

When you reserve a tent & any accessories, we immediately remove them from our inventory and schedule crew. These items become unavailable to other potential customers. Therefore, a non-refundable 50% will be taken at the time of reservation, any cancellation received within 14 Days will be charged 100% of the total rental order.

Tent Installation

Installation of a tent must be done correctly for the protection of the users, the tent, and ultimately the success of your event. Therefore, it is our strict policy that all installations and takedowns are done by our experienced crews. All prices quoted will include these Services.

Delivery

Delivery will be provided for a nominal fee based on location of event. Fees for delivery service are based upon location and specific services requested Standard delivery service includes unloading and neatly stacking equipment on the dock, in the garage or any another mutually convenient place within a reasonable distance of our truck. Equipment should be returned and stacked in the same location for our crew to pick up following your event.

Set Up & Tear Down

Our rates do not include carrying of equipment up or down stairs, or more than 50 feet from our truck. If necessary, 'Special Service' arrangements can be made in advance of for a nominal fee. We will be happy to accommodate your special needs. Please allow time to inspect and count all equipment upon delivery, and to verify our counts upon pick up. Discrepancies must be addressed at the time of service. Full service set up and take down of other items, such as tables and chairs are available at a 10% charge. These arrangements must be made before your scheduled service

Preparation for Installation and Takedown

The first step our crews take installing a tent is to spread it flat on the ground where it is to go up. Please have the area completely clear of obstructions before we arrive at the job-site. In like manner, the tent must be totally empty before we can take it down. Fees will be applied if these policies are not met. The tent crew must be notified of any under ground water, electrical or sewage lines.

Permits

It is the responsibility of the renter to check with your Building Permit and Fire Departments prior to the installation date to confirm the requirement of permits. We will call "JULIE" to check for underground utilities the week of your event. We will assist you in any way possible, but these clearances do remain the responsibility of the renter.

Weather

Client understands that tents are temporary structures designed to provide limited protection from weather conditions, primarily sun and rain; however there may be situations, particularly those involving strong winds and lightning, in which the tents will not provide protection and may even be damaged or blown over. Evacuation of tents to avoid possible injury is recommended when severe weather threatens the area where the tents are erected. People must leave the tents and not seek shelter in tents during such conditions. It is best to evacuate when in doubt. Party People Rental offers an on-sight technician during the event for an additional charge to assist with weather assessment and equipment maintenance. If Client declines those services, Client understands that it is Client's responsibility to be aware of changing weather conditions and to exercise its best judgment with regard to the evacuation of tents. Client agrees that in the event of a predicted or actual storm or excessive winds, Party People Rental may dismantle any equipment that has been previously installed to ensure safety of all involved.

Damages & Damage Waiver

Party People Rental Company does its best to protect your property during the delivery, installation and removal process. Client agrees to release PPRC of any liability for any damage to any property due to delivery, installation and removal of equipment on your property. This includes but is not limited to underground sprinklers systems, septic systems, ruts in grass, scratches or cracks on the installed surface, and high wind related damages, or any other property damage not mentioned. Client also understands that tents are a temporary structure and may leak during heavy rain.

Indemnification & Defense

Client agrees that if any legal proceedings are brought against Party People Rental Co. to recover compensation for injuries to individuals or damages to personal property occurring in connection with the event Client will provide a defense for Party People Rental Co. and any of it's employees named in such proceedings and will indemnify Party People Rental and it's employees for any judgment rendered against them.

Authorized Signature
